Understanding EUC Bandings

The End User Category (EUC) is a site level code provided by Xoserve encompassing the site location / load factor / AQ banding (Annual Quantity) consumption as shown below:

- Band 01 AQ between 1 - 73,200 kWh
- Band 02 AQ between 73,201 - 293,000 kWh
- Band 03 AQ between 293,001 - 732,000 kWh
- Band 04 AQ between 732,001 - 2,196,000 kWh
- Band 05 AQ between 2,196,001 - 5,860,000 kWh
- Band 06 AQ between 5,860,001 - 14,650,000 kWh
- Band 07 AQ between 14,650,001 - 29,300,000 kWh
- Band 08 AQ between 29,300,001 - 58,600,000 kWh
- Band 09 AQ between 58,600,000 - 900,000,000,000 kWh

NB: We do not offer deemed prices for EUC bands 4 to 9; these are dealt with as 'priority customers' due to the size and type of supply, and will be priced accordingly. New contracts must be agreed in order for each supply to continue.
